Since Cr (VI) may not be uniformly distributed in the coating even within the same sample batch, a "grey zone" between 0.10  $\mu\text{g}/\text{cm}^2$  and 0.13  $\mu\text{g}/\text{cm}^2$  has been established as "inconclusive" to reduce inconsistent results due to unavoidable coating variations. In this case, additional testing may be necessary to confirm the presence of Cr (VI). When Cr (VI) is detected above 0.13  $\mu\text{g}/\text{cm}^2$ , the sample is considered to be positive for the presence of Cr (VI) in the coating layer. Unavoidable coating variations may influence the determination Information on storage conditions and production date of the tested sample is unavailable and thus Cr (VI) results represent status of the sample at the time of testing.
